

Goal Progress and Action Plan Review

K-12 Regular Attendance Improvement

Year 2

All schools improved except New Bloomfield (range: .4-7.8%) but Only Blain Elementary met target

Action Plan Review:

- All schools posted attendance plans for 2023-2024 school year
- Schoology is being used to communicate with students/parents at the secondary level
- A-TSI Plan addresses attendance at HS
- Attendance Liaison continues to support students and families

Goal Progress and Action Plan Review Implementation of K-12 Social-Emotional Learning

Year 2

- -Met the target of providing professional learning for K-12 faculty
- -Administered and analyzed Climate Survey
- -MS and HS Faculty and Student SEL sub-scores were below 2.4
- -Principals monitored, reviewed, focused collaboration and student performance measure (SPM)

Year 2 WPMS DID meet target of meeting statewide growth standard goal -DECREASE 7.5


WPMS DID NOT meet the target of 10% increase in achievement -INCREASE 6.4%

WPHS DID NOT meet target of meeting statewide growth standard goal

-DECREASE 42

WPHS DID NOT meet target of 10% increase in achievement -DECREASE 38.8%
